## Conference: Shannon Eagan and Alexis Guay

- Numbers are lower, currently 244 registrants plus conference committee members brings it to 267. 330-350 in prior years.
- Everything is on schedule.
- May need help moving attendees out of eating areas to stay on schedule

- Over 700 attendees numbers are down but most likely to the changes with timing and prior prior year. More events in January.

- Will have signage in vendor area for collections of college t-shirts. Hoping to also solicit new members.

## Development: Stephanie Wells\*

## Membership: Ben Parsons and Jolene Coakley

- Jolene is caught up with checks. Will be at registration table for conference.
- Thanks from Shawn to Ben and Jolene for their work in getting membership registration up and running.

### **Comments:**

- Shawn: how is membership registration process with new site? Depends, there have been some issues.
- > Greg: has been able to reach out to those having issues for the most part
- > Ben: fewer "holes" for members to slip through with new site.
- > Shawn: history/profile section for members will be helpful for MASFAA. Will encourage members to complete it as part of conference.
- > Ben: is there a way to link information to LinkedIn? Per Greg, doesn't think is possible.

## Technology: Greg Chick and Julie Wickstrom

- Thanks to Julie for all her help with new site.
- Actively monitoring registration and membership. Listserv is still in progress. Using MailChimp now to send out messages. There is functionality to send messages from website but not exactly what we had previously.
- Set up online store for vendors to pick what they wanted to sponsor. Will push forward with developing other new features and keep us posted.

#### **Comments:**

- Emir: will there be functionality to have MASFAA specific email addresses? Per Greg, that won't be an option.
- ➤ Keith: will there a mobile app? Yes but need to be a MASFAA member so it won't be as helpful for FAFSA Day.
- > Shawn: would we want to have access to site for different membership levels thinking of FAFSA Day? Greg would take a lot of configuration but in the long run could be helpful.

- ➤ Shawn: is it possible to reactivate old listsery? Try with another vendor?
- > Greg: any ideas? Nelson at Noetic is not interested. Shawn will reach out to EASFAA.
- > Sue: if continuing with MailChimp, may have to change payment process. October/November are high volume months need more access.
- ➤ Kristen: still OK to send messages via website? Yes, but only going to current members.
- > Jim: can we import into non-membership category? Only have emails, not names, etc.
- Michele: quick online search, L-Soft listserv, can have up to 500 subscribers, we have 1400.
- > Shawn: EASFAA uses a couple of options he will research. He also offered a HUGE thank you to Greg for all his time and efforts in setting up new website.

## Communications: Michele Kosboth

- Messages going out on Facebook. Focused on communicating via social media outlets.
- Can post to Facebook page. Sue will post during awards ceremony.
