President Tony Erwin called the meeting to order at 10:05AM.

PRESIDENT'S REMARKS

- Conference approaching!
- Recent change to conference program. Larry Zaglaniczny from NASFAA will give us a federal update as well as update on NASFAA matters.
- Tony gave fed update at RIASFAA meeting and learned about Rhode Island sponsor/exhibitor issues which are very different from ours. Their new president works for RISLA. Considering changes but only 8 member schools, which is problematic for them when it comes to finding new leadership. Tom Threlkeld stole Tony's thunder by giving the same update he gave in June. Had a discussion regarding loans and loan processing. Most schools had not started thinking about 08-09 loan processing. Spoke with Bill Cheatham (EASFAA president) who will be presenting at our conference.
- Retired member bylaw change has been created so 10 year active members, now retired, who wish to have a membership get it free plus 50% off conference fee. Will be voted on by EC and added to ballot for vote at conference.
 - ⇒ Motion offered to add the bylaw change to the upcoming voting ballot offered, seconded and unanimously approved.
- White paper is ready for first look. Requested by one exhibitor and one institution. Breakout of 07-08 budget was made to make some delineation of where money is spent. See handout. General agreement that this breakdown is a sufficient accounting of how MASFAA budget is allocated. Tony will complete document so it can be distributed.
- Discussion about membership dues included whether they should increase but countered by further review of our offerings. May add a question on ballot about threshold for membership dues (for budget decision makers only) or consider a survey after the conference to director. There is the possibility of members being charged for trainings, etc. in case income is needed. Increasing dues would require a bylaw change and could not appear on a ballot until 2008 at earliest. EASFAA charges \$25 for trainings. Tony mentioned that we are at a point where membership is strong and we should be careful not to discourage membership by increasing dues. The thought was to perhaps add this issue to the strategic planning process; Bernie suggested a discussion document for members along with a survey.

• NYSFAA had HESC coordinate exhibitor room and NYSFAA had no contractual agreement to provide an exhibitor room. Instead it was paid for and organized outside of their association.

- Current sites for 2008 are 21. North Shore Community College, in Lynn has been added since the last report. A site in Hyde Park is still a possibility.
- The Lumina Continuation Grant Application was approved for \$50,000 over the next three years (\$25,000; 15,000; 10,000).
- The first call for volunteers went out via the MASFAA Listserve on October 3rd. Up to that point, we had 31 volunteers, who are mainly site coordinators and steering committee members. 49 volunteers registered the week following the email. We currently have 80 volunteers. We are more than two months ahead of where we were last year with respect to volunteers.
- A dozen students are currently registered to attend. FAFSA4Caster added as a resource for students and parents on the website.
- Other web activity shows that summer is active and our visibility is increasing. Average sessions per day from 6/1/06 to 7/31/06 increased from 48.8 to 81.54 from 6/1/07-7/31/07. From 9/1 to 10/17, the average sessions per day increased from 41.96 to 60.68 during the same time period in 2007. A session is a series of hits by one visitor.
- Will be receiving and using a national video PSA (for TV) spot geared toward students, another geared toward parents and four audio PSA (for radio) spots geared toward students and parents in English and Spanish. Will be updating our own video PSA in Spanish for TV.
- Will be partnering with Telemundo as a media sponsor who will give higher level visibility to our PSAs and will give us a free booth at their event, La Feria, a large Hispanic family event that draws about 10,000 people to the Bayside Expo Center. The event is November 18th. This is a significant opportunity for CGS to meet our goal to improve connections with Hispanic students and their families.
- Paul talked about statewide outreach that has been ongoing and aimed at counselors (guidance directors, college access counselors, etc.).
- Paper FAFSA availability will be limited, but CGS plans to have enough for everyone. Electronic FAFSA will be a greater focus going forward. CGS reps from each state will be attending training conference. Gail and Cathy to attend.
