- The Lumina Foundation for Education has accepted the 2008 Massachusetts College Goal Sunday grant report along with payment of the Lumina Continuation Grant 2nd year disbursement of \$15,000. The August 2008 letter from Lumina hails "Massachusetts is one of the most progressive College Goal Sunday programs in the nation. ... As such, Massachusetts is a leader in executing effective strategies that engage the target population." The letter also includes data that compares CGS attendee statistics to Massachusetts state census figures. These figures show our continued success in nearly all target areas. The letter will be attached to the minutes.
- Current sites for 2009 are 28.
- We have begun to hear back from donors, including ASA, MEFA and Citizens Bank. Unfortunately, TERI and Sallie Mae will not be able to make a donation this year. Mass Mutual Insurance (from Springfield, MA) has expressed interest in donating toward the western sites and we are speaking to them about a modified donation. We very well could end up with less income than expenses and will have to use some of the reserves. With the MASFAA donation, that currently brings us to \$55,000 and projected expenses of \$74,000.
- The first call for volunteers will go out via the MASFAA Listserve in early October.
- We will be revising our look this year and modifying the printed materials to be more efficient in printing costs. Instead of printed regional posters, the posters will be generic with a space to write in the local site information. Lesser used languages (Portuguese) will be available for download only (not printed). We will also have a tri-fold brochure instead of a postcard.
- Three students are currently registered to attend.

- CGS will be an exhibitor at the fall MASCA conference and will have a CGS flyer in all the registration packets. 375 counselors are expected.
- College Goal Sunday and Lumina Foundation for Education will be partnering with the YMCA instead of NASFAA as of 2009. The joint letter from Lumina President and CEO, Jaime Merisotis, and NASFAA President, Dr. Phillip Day, will be attached to the minutes. The mission of the YMCA and the existing programs geared toward college access makes this a natural fit. The YMCA is also involved in the KnowHowToGo campaign. In addition, the YMCA is one of the largest youth-serving organizations in the nation. The national support for state CGS programs will continue under the leadership of Marcia Weston and Johnavae Quinn Campbell as employees of the YMCA.
- Info for sponsors can be found on CGS website
- Could have less income for CGS than last year. Looking at total budget of \$75000, budgeted for \$79000. Not all educational prize drawings are claimed. Looks like about \$40-45,000 in donations plus \$15,000 in Lumina funds, so it's possible for CGS to be under funded. Gail said she could cut Castle Group (PR/media) but they are a valuable asset. May be able to cut media campaign from 4 months to 2 months. Another recommendation was to do one education prize drawing that includes all registrants (instead of one prize drawing per site). Gail believes scaling back both the campaign length and prize drawings would be the best steps at this time.

- Terry Hartle came and received feedback on reauthorization act. Regional hearing starting this
  week to get concerns on legislation. Need to negotiate Title IV, but need feedback on non-Title IV
  issues. Lots to sort through.
  - O Asked that MASFAA come up with five points we are concerned about, and then submit detailed policy for review of each one.
  - O Narrowed down list to 5 issues, will have something to review soon via e-mail:
    - 1. Disclosure of estimated net price for first time freshman and calculator estimating merit and need based awards.
    - 2. Title X- private loans, brand new. Applying FFEL rules to private loans (sort of). Many questions regarding responsibilities and we can't negotiate on it.

- 3. Disclosing alumni career placements after graduation.
- 4. Peer to peer file sharing- tech. limitations. Michael offered opinion that we have no relation to this issue. Christine agreed, but committee vote does not. There are concerns about intertwined issues that could be tied to aid through PPA, etc. On a point such as this, we have no expertise; it should probably be taken up by appropriate offices on campus and may need to be brought to the proper people's attention.
- 5. Title VI- international education- polling for areas of greatest need and reporting progress. Another difficult issue for us to speak to.
- There are a few other issues at hand, but they do not have a financial aid slant; except for a text book piece which aims to make access to text book pricing information.
- Various concerns were voiced about other issues, such as VA Benefit changes and unsubsidized loan changes, Pell cap on # of semesters, ACG/Smart changes (award year vs. acad. year)
- Christine's proposal will be to send out e-mail with response deadline. EC members must respond immediately for vote. Consensus is to focus on financial aid related issues. Gail suggested we consider the scope of how many institutions are affected by each issue.
- Kathy reiterated that she hopes for a Govt. Relations committee member to be on neg reg
- Michael brought up verbiage of CCRAA in regard to Public Service Loan Forgiveness, a semicolon
  was removed that changes the meaning of what types of jobs are included (either all 501c3
  employees regardless of role, or just roles that are listed). The semicolon is the key. Fear and
  respect the semicolon.

# Dear College Goal Sunday Volunteer Leaders:

Since its small beginning in 1990, College Goal Sunday has grown into a formidable charitable initiative. This past year alone, it helped more than 30,000 students and families across 37 states complete the universally required federal financial aid form (FAFSA). Annual evaluations tell the story of a program that volunteers – many of whom are NASFAA members -- take pride in providing and that beneficiaries appreciate as helpful and effective.

The growth in the program has relied on the collaborative efforts of scores of organizations and the goodwill of hundreds of volunteers. The actors have sometimes shifted roles to accommodate the program and their own needs. As a result, the program has been supported by many benefactors and has been able to grow and adjust with the times.

This letter is to let you know that the program is preparing to gear up for 2009 even as it undergoes one more evolutionary shift in its administrative structure. For the past several years, the National Association of Student Financial Aid Administrators (NASFAA) has assisted lead funder, Lumina Foundation for Education, in administering the program. The results have been impressive: CGS has expanded its volunteer network from 18 to 37 states, and more are in the pipeline.

Based on that success in building the volunteer network, CGS appears poised to reach out to many more families who need help qualifying for financial aid. To that end, the national YMCA organization has expressed interest in helping to increase the outreach of CGS through its expansive network of facilities and programs across the nation. The national YMCA has many avenues to reach one of our target populations -- low-income, disadvantaged students. The YMCA can reach these students in their early years, before they decide whether they will pursue a postsecondary education.

NASFAA will continue in a cooperative role with CGS. We anticipate that the CGS staff – Marcia Weston and Johnavae Quinn Campbell – will continue to manage the program, but as employees of the YMCA. They will continue to serve as liaison with all of the state-based CGS programs. Lumina plans to continue as a major funder of the program.

A partnership with the YMCA makes sense at many levels. The Y has already committed itself to college access through its Black and Minority Achievers programs and through its involvement in KnowHowToGo, a pre-college access awareness program cosponsored by ACE, Lumina and the Ad Council. In addition, the Y, as one of the largest youth-serving organizations in the nation, is committed to using its vast network of facilities and personnel to community outreach. The Y is eager to partner with CGS and to cooperate with NASFAA to expand the program's reach and effectiveness. Although the YMCA's full involvement in the program will not become evident until the 2009-2010 academic year, the coming year will provide that bridge to the future.

Volunteers from the financial-aid community remain the lifeblood of CGS, and they will continue to be the backbone of the program. You have our sincere thanks for that support and our hope that you will be energized by the opportunity to expand the reach of CGS and other college access efforts in the coming years.

Outreach efforts and partner support continue to result in positive outcomes for the Massachusetts College Goal Sunday program. Already their strongest target population, Massachusetts College Goal Sunday increased their number of Black participants by another 1 percent in the race category. They also did very well reaching Asian/Pacific Islander, American Indian/Native American and Multiracial target groups. With regards to the Hispanic population, I recommend contacting the College Goal Sunday National Network for Hispanic families contact person Juan Garcia to discuss other ways to continue to reach the Hispanic population.
