Events discussion:

Just the FACTS! series implementation:

- We've scheduled five 1.5 hour sessions Wednesdays at 2 pm between 12/9/2020 1/27/2021.
- Topics include: COA & Application Process, SAP, Need Analysis, Verification, Pell Grant. Discussed possible later spring sessions for more advanced topics, like DL and R2T4.

Spring Training: Committee was unable to hold training in May 2020 due to pandemic. Will look to schedule something virtually. This cycle will be for support staff, likely virtual, May/June. Committee members will consider topics for next meeting. Plan will be to cover 2-3 topics over 1-2 hours.
