FAFSA Day: Amy

- We are nearing the end of the presentations
 - o 1 on Sunday which is the 2nd Spanish session
 - 34 signed up
 - The next is Thursday
 - 251 signed up
 - o Participation is great as the people who signed up actually show up
- We partnered with MEFA with our FAFSA challenging and awarding scholarships
 - Increasing awareness around FAFSA
 - o FAFSA filing down and in MA about 9 percent down
- Amy will be a panelist next week at 2pm
 - Two presentations
 - They are trying to have conversations with guidance counselors
 - Panel is a few people just talking about what they are doing while navigating through this
 - They are working on a toolkit
 - This will go on the FAFSA website, where you click on it and open the toolkit
 - There will be resources such as recorded presentations, one English and one Spanish presentation
 - People can use this and send out to families, whether it's people in our community or on the high school level
 - We are creating a robust FAQ
 - Being remote and doing sessions victurally means that we have a transcript of all the questions and answers
 - Checklist will also be a part of the toolkit
