FAFSA Day- Jennifer Bento-Pinyoun

- Hosted a FAFSA open virtual presentations on 10/13
- Amy did a great slide presentation and went through form line by line and answered FAFSA questions from families
- 175 people attended
- Sessions were followed up with an email and recording. Recording is posted on FAFSA.org site
- Continuing with monthly sessions through February. Offering drop in one-on-one support sessions
- Families are paired with expert volunteers in a break out room
- Spanish and Chinese speaking volunteers
- Promoting FAFSA assistance opportunities on social media platforms
- The MEFA College Planning team is answering phone lines and addressing FAFSA questions
- Website: <u>fafsaday.org</u> updated with resources
- Beth asked if there are any sponsors or scholarships for FAFSA Day?
- Jennifer advised that invoices were sent regarding sponsorships to ASA and MEFA
- Beth advised that she has not yet received those funds and will be expecting those checks

Access, Inclusion and Diversity Committee: Jaron and Tanika

- No major updates
- Focusing on building out framework on the program to support low income and first gen students
- Jody Conway is primarily leading the research and getting the main school and Barnstable High School on board as test sites
- Committee would like to request a table at the conference in hopes of bringing more awareness and support and will be asking for mentor volunteers
- Committee is having difficulty finding presenters
- New committee member Kris Smole, also on FAFSA Day Committee
- Amy mentioned that the student panel and presenters from Financial Literacy symposium could be good resources
- Tanika will be reaching out to Jody for additional information
- Dan commented there is an overlap in committee goals between the Financial Literacy and Access, Inclusion and Diversity committees and suggested working together

Development Committee: Donna

- 25 sponsors have signed up
 - o 24 exhibiting
 - 1 cancelation request, will talk about during conference update
 - $\circ \quad \text{All but 5 have paid in full} \\$
 - Due date for payments November 10th
- Proposal to let exhibitors know attendance numbers in order to give vendors the opportunity to cancel due to low attendance
- Refund options were discussed
- Amy noted that she had spoken with sponsors who were asking for some sort of refund due to low attendance
- Vendors could be waiting for numbers before committing to attend the conference
- Betsy suggested that if a refund is issued it should be made clear that it is a one-time exception due to COVID-19, only authorized to refund under the HEROES Act
- Julie advised the refund discussion is on the agenda for today's Conference Committee update
- There are currently 101 registrants, over 40 are vendors
- Julie commented that there is room for us to be proactive in refunding money in advance. Committee could work on figuring out what is an appropriate dollar amount as a good will gesture to refund vendors due to low conference attendance vs. high number of vendors
- Jeff reported updated numbers of 106 total registrants, 35 exhibitor/sponsors, 71 school related

Early Awareness: Katelyn

- No updates from last meeting
 - Reaching out for volunteers and assistance for Fall 2022
- Acting as Committee Chair and looking for assistance. Event will require all hands-on deck
- In the process of determining if the event should be in person or remote
- Event is in the planning stages and still being researched
- More information should be available next month
- Open to ideas, feedback, and assistance

Financial Literacy Committee: Jenn and Dan

- Virtual symposium went very well, themed around financial aid and financial administrator wellness
- Dan shared overview of symposium
- Symposium video link was emailed
- Committee is planning an event for early December
- New Members: Elizabeth Lally and Tasha Nunez
- Continuing to work on 1st generation communication
- Event could potentially be a podcast or webinar
- Jenn: November conference sessions offerings are in place
- Dan: updated information regarding the certificate program will be posted

Government Relations: Betsy and Ellen

- Department of Education (ED) made an important announcement on 10/6/21
 - Under the HEROES Act, temporary waiver of many of the requirements for Public Service Loan Forgiveness (PSLF)
 - Currently approximately 16,000 people have received forgiveness under PSLF, under the waivers approximately 22,000 will receive immediate forgiveness under PSLF
 - ED has not yet updated information on website or issued written guidance causing confusion to borrowers.
- Will be doing a webinar with CFPB on November 4th
 - Monica asked is webinar was open to everyone
 - Betsy advised it is open to all and provided the link
 - Monica and Betsy talked about PSLF and possible outreach to alumni and grads
 - Betsy advised she has an extensive updated FAQ page on her site
- Will be presenting updates as part of session conference
- ED: 2nd week of negotiated rule making will start next week
 - Issue on the table: Borrower Defense to Repayment- provides relief when schools defraud their students. Rule applies to all institutions, not only non-profit schools
 - Possible triggers: If a school gets up to a certain number of appeals they may be required to acquire insurance or have escrow accounts in order to cover costs of appeals
 - Will update once outcome has been determined
- Infrastructure bill: Originally contained America's College Promise, free 2-year college and easier pathway for students to transfer from 2-year degree to a 4-year degree. This is no longer on the bill and there is a new proposal. Will update and summarize at a later date.
- Betsy noted if anyone would like to sponsor a webinar for PSLF she is willing to present
- Monica suggested working with Betsy and presenting several sessions throughout the year
- Ellen: at the government relations committee meeting a suggestion was made to expand membership by offering MASFAA membership to other states.

 ME, NH, RI showed interest. A NH person from a 2-year public community college was at meeting and was interested in learning about what we were doing in joining forces with the government relations committee, administration of HEERF III funding in MA, PSLF, negotiated rule making.
