Financial Education & Wellness Committee: Jenn

- 1st Webinar on March 2nd, A Problem of Fit: How the Complexity of College Pricing Hurts Students and Universities, Professor Phillip Levine of Wellesley College
 - Over 50 attendees
- 2nd Webinar on March 23rd, Looking Beyond the HEERF Cliff: Building Sustainable Models for Emergency Aid, Tim Lehman, Southern New Hampshire University
- 3rd Webinar will be on April 2nd, Begin with the End in Mind: Assessment and Evaluation for Financial Wellness Programs, Dr. Zach Taylor, University of Texas.
- Looking into how to produce a podcast series
- Monica and Jenn will be co-chairing EASFAA Financial Wellness Committee
- Jenn is no longer main representative for MA and will be rolling off of MASFAA committee
- Since Dan is now working in RI he is not sure if he will remain as co-chair of Financial Wellness Committee
- Will be asking committee members if there is interest for Chairs as well as doing some outreach

Government Relations Committee: Betsy and Ellen

Ellen:

- The State sent the budget to be signed off, \$22 million for high education private schools in that budget
- Not sure if MASSGrant will be increased
- The State collected the highest collection rate of taxes ever this year resulting in the budget proposal looking positive for higher education.

Betsy:

- Betsy stated that most of the negotiated rule making proposals did not come to consensus
- Neg/Reg session was about gainful employment. This is the 3rd Administration that tackled these issues
 - Obama Administration-while the proposals apply to all schools, can't say they were not targeting specifically for profit schools
 - o Trump Administration- pulled back on all of proposals
 - The current proposals are meant to put more protections in place for students
 - o 90/10 Rule did come to consensus, for profit schools
 - Eliminates the loophole that is currently in place where funds from the military are not counted, i.e. GI Bill.
 - Will include language about income share agreements
 - Not going to count funds received for Non-Title IV eligible programs
 - Gainful Employment proposal will include language regarding a new metric where the median earnings of graduates from a gainful employment program will be bumped up against average earnings of people that only have high school diploma
 - Cosmetology schools are proposing that income reported from graduates of cosmetology and hair dressing schools be excluded from the earnings comparison reports. A good portion of income earned by these students is unreported tips so the earnings reported are not reflective of actual income
 - This Neg/Reg also includes information about financial responsibility and administrative capabilities and they are looking to add additional language addressing discretionary triggers. If a school hits one of those triggers the Dept of Ed could put the school on provisional certification and the school would be required to create an escrow fund or take out insurance to ensure that if there are any closed schools or borrower defense discharge claims that the Dept of Ed and the US taxpayer would be reimbursed
- In the near future, expect to see similar proposals and stronger proposals around gainful employment
- Preparing to do regulatory updated training for MASFAA
 - After draft rules come out over the summer
 - After final rule comes out
- Betsy shared thoughts on the extension of the repayment pause
 - o predicts the pause will be extended another 6 moths
 - Hearing chatter that Dept of Ed has advised servicers to stop sending out repayment restart reminders to students
 - President of SLSA, Scott Buchanan, tweeted out a reminder about repayment restart which conflicts with the Dept of Ed advising servicers to stop sending out repayment restart reminders
 - TISLA has discontinued their social media campaign that put a humorous slant on repayment restart reminders

- Betsy shared her thoughts on broad student loan forgiveness
 - Spoke with a Democratic Congressional staffer who is heavily involved with this conversation. This staffer did not think there would be an announcement about broad student loan forgiveness
 - Spoke with a Republican Congressional staffer who is strongly opposed to loan forgiveness. This staffer seemed to think there may be something done on the lower end and based on income
 - Possibly working on a permanent reduction of interest rates
 - Biggest barrier to congress looking into loan forgiveness is the cost
- About halfway through PSLF temporary waivers
- TISLA is conducting a number of webinars and is currently working with Senator Warren's office to see if TISLA can offer a webinar free of charge for Mass State employees.
- Working with colleges and universities about PSLF education
- Ebony stated that she hopes that the loan repayment pause info will be released sooner than later because time is getting closer and it would be helpful to borrowers to know what to expect
- Betsy stated that if they are not going to extend the pause then there is a very small window for robustful outreach that need to be done
- Betsy shared that she does not feel the pause should be extended. The longer it goes the harder it will be to get borrowers in repayment back on track and the pause has cost the Federal Government \$50 billion per year
